Background:

- MASCO has been awarded an 05 and 06 earmark to test and deploy the NAFTRACS project;
 - Lockheed Martin Transportation Systems and Security (Rockville, MD) is part of your project team;
- The University of Oklahoma has received two earmarks totaling \$12M in the most recent Transportation Authorization Bill to pursue end to end containerized freight security solutions:
 - o Lockheed Martin MS2-Eagan, MN. (Maritime Systems and Solutions) is a part of the contractor team:
- Texas DOT, a member of NASCO, has expressed very strong interest in coordinating these

- eefforts in order to make them completely compatibale and supportable;
- Oklahoma DOT and the Oklahoma legislature has expressed the same very strong interest in consolidating these efforts in a manner that would make them completely supportable, compatible, and insure that these projects provide a "force or capability multiplier" versus being pursued as a single end-game project;

Recent Events:

Both LockheedMartin Business units (MS2-Eagan and TSS-Rockville) have formally agreed (with Corporate approval and support) to integrate these projects in a manner that each are mutually supporting, complimentary, build on the other --- in complete consideration that these are DOT funds --- and completely support both DOT and DHS freight mobility and security requirements.

Additional Actions That Must Be Taken:

While the two major contractor teams have agreed to this project integration --- which all parties will agree make absolute sense and is a wise expenditure of public funds --- This integration cannot commence without the support of the University of Oklahoma and its Program Director, Dr. Thomas L. Landers, Dean, College of Engineering, Carson Engineering Center, University of Oklahoma, Norman Oklahoma.

Requested Action:

- If you are in agreement with the integration of these projects in a manner that insures that both are complimentary in every way, please contact Dr. Landers with the objective of securing his active support for this initiative.
- We, the NASCO contractor team, will not proceed on development of an independent Proof of Concept project in anticipation that this mutually supportive initiative will be approved by Dr. Landers.
