SC02 INSURANCE TERMS

Contractor personnel are employees of the Contractor and are paid by the Contractor on the basis of services rendered. Where the Contractor or the Contractor's employees are providing services on government premises pursuant to this Contract and the said premises become non accessible due to evacuation or closure of government offices, and consequently no Work is being performed as a result of the closure, Canada will not be liable for payment to the Contractor for the period of closure.



General

The insurance policies required on page 1 of the Certificate of Insurance must be in force and must include the insurance coverage listed under the corresponding type of insurance on this page.

The policies must insure the Contractor and must include Her Majesty the Queen in Right of Canada as represented by the Minister of Public Safety Canada as an additional Insured.

The insurance policies must be endorsed to provide Canada with not less than thirty (30) days notice in writing in advance of a cancellation of insurance or any reduction in coverage.

Without increasing the limit of liability, the policies must protect all insured parties to the full extent of coverage provided. Further, the policies must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.

Commercial General Liability.

The insurance coverage provided must not be substantially less than that provided by the latest edition of IBC form 2100.

The policy must either include or be endorsed to include coverage for the following exposures or hazards if the Work is subject thereto:

- blasting;
- b) pile driving and caisson work;
- underpinning; c)
- removal or weakening of support of any structure or land whether such support be natural or otherwise if the work is performed by the insured contractor.

The policy must have the following minimum limits:

- \$5.000.000 Each Occurrence Limit:
- \$10,000,000 General Aggregate Limit per policy year if the policy contains a General Aggregate; and b)
- \$5,000,000 Products/Completed Operations Aggregate Limit.

Umbrella or excess liability insurance may be used to achieve the required limits.

Builder's Risk / Installation Floater.

The insurance coverage provided must not be less than that provided by the latest edition of IBC forms 4042 and 4047.

The policy must permit use and occupancy of any of the projects, or any part thereof, where such use and occupancy is for the purposes for which a project is intended upon completion.

The policy may exclude or be endorsed to exclude coverage for loss or damage caused by asbestos, fungi or spores, cyber and terrorism.

The policy must have a limit that is **not less than the sum of the contract value** plus the declared value (if any) set forth in the contract documents of all material and equipment supplied by Canada at the site of the project to be incorporated into and form part of the finished work. If the value of the work is changed, the policy must be changed to reflect the revised contract value.

The policy must provide that the proceeds thereof are payable to Canada or as Canada may direct in accordance with GC10.2, "Insurance Proceeds" (https://buyandsell.gc.ca/policy-and-guidelines/standards-acguisition-clauses-and-conditionsmanual/5/R/R2900D/2).

Contractors Pollution Liability

The policy must have a limit usual for a contract of this nature, but no less than \$1,000,000 per incident or occurrence and in the aggregate.

ANNEX - C - STATEMENT OF WORK

Shipping of Temporary Kitchen

General Information

CORCAN Construction Ontario Region has a requirement to ship a four section modular building and one sea container from Collins Bay Institution in Kingston ON to Warkworth Institution in Campbellford ON.

Background

The Mandate of CORCAN Construction is to provide employment and employability skills training to offenders incarcerated in federal penitentiaries. When deemed appropriate by CORCAN Construction, the Contractor may be required to assist in the Mandate by working with 2-4 Offenders. The Offenders will be supervised by CORCAN. The Offenders will be considered unskilled labour and the Contractor will help them gain knowledge and skills in the trade(s) being carried out. The Offenders are employed by CORCAN Construction and no financial obligations are required of the Contractor as a result of having them as part of the workforce. The Offenders are considered to have the potential to be productive upon receiving training necessary to their work and will be removed or replaced upon request from the Contractor should they not show improvement or interest in the work they are tasked with.

Scope of Work

The Contractor must supply all labour, material, tools, equipment, transportation, and supervision necessary to complete the Statement of Work as detailed:

- 1. The Contractor must mobilize trade professionals and equipment to Collins Bay Institution to prepare and load the four section modular kitchen and sea container units and transport to Warkworth Institution.
- 2. The Contractor must work with CORCAN Construction staff to separate and load the modular sections as required.
- 3. CORCAN Construction will be responsible to secure all openings, and apply house wrap prior to the move to ensure the building sections are weather tight and safe for transport.
- 4. CORCAN Construction will ensure all building contents and equipment are secured.
- 5. The Contractor must acquire and hold all permits for the complete move of the Temporary Kitchen unit throughout the project.
- 6. The Contractor must transport the temporary kitchen units and sea container to Warkworth Institution for staging and setting.
- 7. The Contractor must construct temporary granular pad for crane and staging area as required.
- 8. The Contractor must construct temporary perimeter by pass road for security and emergency response vehicles.
- 9. The Contractor must provide crane, and all lifting equipment/ materials required to lift and set the modular units safely over the perimeter fences.
- 10. The Contractor must provide all equipment/ materials required to set all units in place on the surface foundation system, approximately 35 meters to center, inside of the perimeter fencing.
- 11. The Contractor must remove and restore granular crane pad, staging areas, and temporary by pass road.
- 12. The Contractor must provide topsoil and seed restoration services to all disturbed areas.
- 13. The Contractor must ensure the building is delivered, and set in the same condition and configuration as it was prior to the move. final placement of the building and sea container must be signed off by CORCAN Construction representatives before demobilization.
- 14. Weatherproofing and final stitch by others.
