The eighth-graders got their Discovery Degree Natalie Gatz, Dianna Scott, and this year's star winner was too close to pick just one so, Dani Doerr and Makenzie Doerr both got Star Discovery plaques. This degree is based on being active in FFA.

The Freshman received their Greenhand degrees: Wyatt Doerr, Karter Lingenfelter, Baili Prewitt, and Corben Kment received a star, Greenhand Degree.

The Greenhand is based on being active in FFA and learning about FFA and having an SAE is what members are doing outside of school and keeping records.

The sophomores received their chapter degrees, Brendan Weber, Spencer Hillie, Roni Prewitt, Brooke Rafert, Grayson Pe-

The star winners were Abbie Kromareck who received a star in Ag Business, Kaiden Eichberger received star placement, and Reagan Choat received Star Farmer all at the chapter level.

FCCLA Members will begin calling past donors for a donation time. Walk-ins are allowed if there is a current opening. Waiting for an opening while on site is not allowed.

Individuals who are 17 years of age (16 with a completed parental permission form), meet height and weight requirements (at least 110 pounds based on height) and are in generally good health may be eligible to donate blood. After testing positive for COVID-19, donors must wait 14 days before giving blood. Please bring a Red Cross blood donor card or other form of positive identification (driver's license). To save donation time, please complete Rapid Pass before arriving. It can be found at https://www.redcross-

The FCCLA Red Cross Blood blood.org/donate-blood/manе donations/rapidpass.html or by using the Red Cross Blood Donor App on your phone.

There is no deferral time if donors have received an inactivated or RNA based COVID-19 vaccine such as Pfizer or Moderna. Donors will need to propointments previously made vide the manufacturer name

when you come in to donate. Upon vaccination they should have received a card or printout indicating COVID-19 vaccine was re-Eligible ceived.

donors who are vaccinated with a replication defective virus COVID-19 vaccine manufactured by AstraZeneca or Janssen/J&J must wait two weeks before giving blood. Eligible donors who do not know what type of COVID-19 vaccine they have received must wait four weeks before giving. Regardless of the type of vaccine received, all donors must be symptom free and feeling well at the time of donation. The Red Cross has imple-

mented additional precautions that donors will notice at the drive:

 hand sanitizer for use before the drive, as well as throughout the donation process

 social distancing between donors including entry, donation and refreshment areas

 routinely disinfecting surfaces, equipment and donortouched areas

· food/drinks in the refreshment area must be single-serve,

individually wrapped packages

Twitting along

This week some national news was made when billionaire Elon Musk made a bid to purchase up the stock of Twitter, a social media platform.

Since Twitter's inception, and Facebook, and all the rest they just gradually become directed and controlled platforms for advertising sharing and information collection, but with a move of one of these platforms changing back to a private company will have some interesting ramifications if Musk gets

The point of today's conversation, however, is the absolute absurdity that surrounded the entire purchase, buyout, offer and news that circulated after the initial offer was made.

Musk had delivered news that he intended to make the offer a week or so ago, and, at that time, news stations immediately started calling the entire idea the "death of free speech" - to move a social media platform back into the hands of a private owner, and yet, Twitter's banning, backdooring and shadow destruction of accounts rival that only of Facebook for flat-out "censoring by algorithm."

Musk's offer was then also met with resistance from the Board members, who created an armageddon scenario if Musk was to make his offer formal - they'd split the shares and flood the company with owners to dilute Musk's share. So then came the actual total buyout. The Board again

balked and complained and the internet Twits took to their Twitting and discounted the entire process and offer. Social justice warriors were out enmass arguing that Musk would destroy their voices, corrupt the social platform, elimi-

nate free speech by censoring whomever he wanted and

rolling back all the "progress" that the internet had made. Twitter is quite literally one of the smallest user-based social media platforms in today's world. Facebook has around 2.2 billion users on a daily basis, down from it's 70 percent saturation a few years ago and Twitter and Reddit seem to be battling for third place. Pinterest, Instragram, Snapchat, WeChat, and a host of others, plus all the local ones, but in the end compared to

Facebook's 2.2 billion, Twitter only has 336 million daily users. Hardly purchasing a large portion of the market. I wondered at the time what the board felt they were so justly defending.

But then, an amazing thing happened. A little thing I like to call 'capitalism wins' even in the face of social justice warriors and people who attempt to toe the line - Musk came through on his fundraising.

He proved to the Board of Twitter that he could, in fact, come up with the \$48 billion some dollars necessary to purchase the entire company, so, they sold it.

In the end, all their hopes and dreams of progress came shattering down just like all the rest - when enticed with enough money, as has been said "everything's for sale."

It will be interesting to see what Musk decides to do with the platform - sole control over 336 million users' activity - is a mighty sword to wield.

Let's see if the new King of Twits can make it or break it.

Your View



Legislative

Update

The One Hundred Seventh Legislature, Second Session, has adjourned sine die.

The last day was filled with last minute items, the governor's closing speech, and ceremonial prothat won't be back in January, eirecognized.

Although I won't be running for

When I ran for office, my priorities were property tax relief, helping veterans, pro-life issues, and water quality. I believe that healthy soil is directly related to the quality of water. During my islation that created the Healthy

informed consent statutes to include information on the abortion pill reversal process. In 2020, I cosponsored LB 814, which prohibited dismemberment abortion. Both of these bills passed. This year, I was a co-sponsor of

LB 209, which updated abortion

both LB 781, which would make abortions illegal if a fetal heartbeat is detectable, and LB 933, which would ban abortions in Nebraska if Roe vs. Wade is overturned this summer by the U.S. Supreme Court. Unfortunately, neither of these bills became law. As a veteran who served for 40

years and by the grace of God avoided serious injury, I wanted to help those who were less fortunate. In 2020, I sponsored legislation to provide disabled veterans with free lifetime state park permits. I co-sponsored legislation that initially excluded 50% of military retirement benefits from state income tax and later offered a full exemption.

Last year, I introduced legislation to prohibit an insurance company from adding a surcharge or increasing premiums for a member of the armed forces if they choose to discontinue their motor vehicle insurance coverage while they are deployed. This year, I introduced a bill to remove the 10year limitation on access to state tuition assistance for members of the Nebraska National Guard.

In 2020, the Legislature passed LB 1107 which provided for a statutory minimum of \$275 million annually for the Property Tax Credit program (shown on your property tax statement). The legislation also created a new refundable income tax credit based on the amount of school district property taxes paid. The annual funding began at \$125 million increasing to \$375 million by tax year 2024.

This year, with the passage of LB 873, the refundable income tax credit will increase to \$548 million for the 2022 tax year and \$560.7 million next year, significantly

higher amounts than anticipated just a couple years ago. Furthermore, a new refundable income tax credit for property taxes paid to community colleges was also implemented, beginning with an appropriation of \$50 million this year and increasing to \$195 million by 2026. The Property Tax Credit program has since grown to \$313 million for tax year 2022 Therefore, property tax relief from these two programs will soon top \$1 billion annually.

It has been an honor to serve the constituents of Legislative District #40. I welcomed your input and listened to what you had to say, while holding firm to the values and beliefs that I ran on. I have met so many wonderful people in the district and have learned a great deal from you. The past four years have been an extremely valuable experience and for that thank you.

I would also like to thank the local papers who publish this column during the legislative session. This helps keep the constituents of the 40th legislative district informed on what is happening in Lincoln.

Even though the legislative session has ended and I will be home in Creighton the majority of the time, I will still travel to my State Capitol office periodically and my staff will be there full-time. 

Silver-Plated Pitchers

Silver-plated pitchers were made by Reed & Barton, a company founded in Taunton, Massachusetts, in 1822. The pitchers look like the double-faced stoneware pitchers made by the Martin Brothers in England between 1875 and 1915. Similar pitchers were also made by Royal Doulton.



Sunny Jim is the name of these two silver-plated pitchers. The two sold together at New Orleans Auction Galleries for \$4,750 in 2019 and could be worth even more now

The silver examples are known as "Sunny Jim." The ones pictured are about 6 1/4 inches high, and each holds about 56 ounces (7 cups) of liquid. Many figural pitchers, steins and mugs had names that were used in advertising brochures. The silver pitchers were pictured in magazine ads in the 1920s and '30s. They were discontinued in the 1950s, but may have been made until the 1980s.

Three slightly different versions were made with different rims. These are probably the first two types of the pitchers. The third variant, which was probably at the end of the production, has a handle with a higher curve that was attached to the rim only at the outermost area of the scroll.

Covers with artistic illustrations or pictures of historical events, old cars or trains, or political events increase the value. Someone who is interested in patriotic music from the World War II era might be interested in your music. It's hard to sell the music yourself unless you're used to selling online. You might try a consignment shop in your area.





• On May 14, 1796, Edward Jenner, an English country doctor, administers the world's first vaccination as a preventive treatment for smallpox. Scientists following Jenner's model developed new vaccines to fight diseases such as polio, whooping cough, measles and tetanus.

- On May 12, 1932, the body of aviation hero Charles Lindbergh's baby is found, more than two months after he was kidnapped from his family's Hopewell, New Jersey, mansion. Kidnapping was made a federal crime in the aftermath of this high-profile crime.
- On May 15, 1942, gasoline rationing begins in 17 eastern states to aid the American war effort during World War II. By the end of the year, President Franklin Roosevelt had made gas rationing mandatory in all 48 states.
- On May 9, 1960, the U.S. Food and Drug Administration approves the world's first commercially produced birth-control pill, Enovid-10, made by the G.D. Searle Company of Chicago. Clinical tests of the pill had begun in
- On May 10, 1980, Treasury Secretary G. William Miller announces the approval of nearly \$1.5 billion in federal loan guarantees for the nearly bankrupt Chrysler Corporation, at the time the largest rescue package ever by the U.S. government to an American corporation. The loan terms required Chrysler to raise another \$2 billion on its own.
- On May 11, 1997, chess grandmaster Garry Kasparov resigns after 19 moves in a game against Deep Blue, a chess-playing computer developed by IBM scientists. It was the sixth and final game of their match, which Kasparov lost two games to one, with
