## REMINDERS:

- ❖ **UC Transferability:** There is a small window of opportunity to submit new courses, and resubmit courses previously denied for transferability. Please check with Bernie Day ASAP but no later than October 12<sup>th</sup>.
- ❖ **AA-T/AS-T Degrees (aka. Transfer Degrees):** By Fall 2013, we will be required to have approved transfer degrees for at least 80% of those TMCs for which we offer degrees (i.e. if we don't already offer a degree in a particular major, we do not have to develop a new transfer degree for that major). By Fall 2014: we have to be at 100%! Bernie is contacting appropriate program faculty directly to ensure we are on track to be in compliance. - ❖ **Repeatable Courses:** Beginning Fall 2013, no courses are repeatable. We've been instructed that if some courses share similar activity types or "families", and students are limited enrolling in a maximum of 6 courses within a given family. We've been given local control to

define "families" of courses but we must proceed with great diligence, as repetition and repeatability are district-wide, not just for Foothill. In coming weeks, the CCC will be discussing how best to approach this conundrum.

## "WE NEED YOUR FEEDBACK!" ITEMS:

- ❖ **English & Math Proficiencies for Certificates of Achievement:** Title 5 mandates minimum math and English proficiencies for associate's degrees but makes no mention of proficiencies for certificates of achievement. Should we have college-wide policy for minimum proficiencies for certificates of achievement, or do faculty feel strongly that program faculty should make the call on a certificate-by-certificate basis? Please share your feedback with your CCC Reps.
