**A RESOLUTION OF THE TOWNSHIP OF HALFMOON, CENTRE COUNTY, PENNSYLVANIA, ADOPTING THE NEW JOINT ARTICLES OF AGREEMENT OF THE CENTRE REGION BUILDING AND HOUSING CODE BOARD OF APPEALS, WHICH INCLUDES REPEALING AND SUPERSEDING THE JOINT ARTICLES OF AGREEMENT FOR THE ESTABLISHMENT OF A CENTRE REGION BUILDING AND HOUSING CODE BOARD OF APPEALS DATED SEPTEMBER 27, 2004.**

**WHEREAS**, the governing bodies of the Borough of State College, and the Townships of College, Ferguson, Halfmoon, Harris, and Patton, all of Centre County, Pennsylvania, are members of the Centre Region Council of Governments (COG); and

**WHEREAS**, the Joint Articles of Agreement of the Centre Region Council of Governments provide for separate agreements for COG programs; and

**WHEREAS**, cooperation amount the municipalities in the exercise and performance of their governmental posers, duties, and functions, is authorized by the Act of 1972, July 12, P.1. 762, 53 P.S. Section 481, et seq., as amended, and by the Act of 1982, June 12, P.L. 512 No. 141, 42 PA C.S.A. 8951, et seq.; and

**WHEREAS**, the Borough of State College, and the Townships of College, Ferguson, Halfmoon, Harris, and Patton wish to adopt a new Joint Articles of Agreement of the Centre Region Building and Housing Code Board of Appeals, which includes repealing and superseding the Joint Articles of Agreement for the Establishment of a Centre Region Building and Housing Code Board of Appeals dated September 27, 2004.

**NOW, THEREFORE, BE IT HEREBY RESOLVED** that the Board of Supervisors of Halfmoon Township, Centre County, Pennsylvania:

**SECTION 1:** The Board of Supervisors of Halfmoon Township hereby adopts, by reference, the new Joint Articles of Agreement of the Centre Region Building and Housing Code Board of Appeals recommended by the COG General Forum on September 29, 2020, a copy of which is attached to this resolution as Exhibit A.

**SECTION 2:** The Chair of the Halfmoon Township Board of Supervisors of Halfmoon Township is hereby authorized to execute said Articles on behalf of Halfmoon Township.

**SECTION 3:** The existing Articles of Agreement, and any other previous Articles of Agreement in conflict herewith are hereby repealed and superseded.
