A RESOLUTION to approve annual events by 501(c) organizations in accordance with the provisions of Article XI, Section 5 of the Constitution of Tennessee, and pursuant to the Tennessee Nonprofit Gaming Law.

WHEREAS, Article XI, Section 5 of the Constitution of Tennessee, as implemented by the provisions of the Tennessee Nonprofit Gaming Law, requires each annual event operated for the benefit of a 501(c)(3) or (c)(19) organization located in this State to be authorized by a two-thirds vote of all members elected to each house of the General Assembly; now, therefore,
