Baker Donelson Boosts Labor Group With Ex-Ogletree Atty

He eventually left the firm, along with several other lawyers, to form Lewis Fischer Henderson, which later merged with Ogletree.

Lewis is looking forward to helping expand Baker's employment practice in the eastern part of Tennessee, a region he said had been traditionally "underserved in the employment law part of the business."

An avid water-skier and a self-professed "snappy dresser" and "good dancer," Lewis seems to have a streak of fun in him. Perhaps that's why he appears so sanguine about joining Baker.

"It's an opportunity to do what I do with people that I enjoy," he said.
