2 **JUDGE, THE OFFICE OF THE UNITED STATES TRUSTEE, THE DEBTORS, ALL**  
3 **INTERESTED PARTIES AND/OR THEIR COUNSEL OF RECORD:**

4 **PLEASE TAKE NOTICE** that on August 15, 2018 at 11:00 a.m. (the “Sale Hearing”),  
5 or as soon thereafter as the matter may be heard, the *Motion for Entry of Order (A) Approving*  
6 *Sale of Property Free and Clear of Liens and Encumbrances Pursuant to 11 U.S.C. § 363(b) and*  
7 *(f), (B) Finding Purchaser Qualifies as a Good Faith Purchaser Pursuant to 11 U.S.C. § 363(m),*  
8 *(C) Approving Overbid Procedures, and (D) Waiving Fed. R. Bankr. P. 6004(h) Stay* (the  
9 “Motion”) filed by David K. Gottlieb (the “Trustee”), the duly appointed, qualified, and acting  
10 chapter 7 trustee for the bankruptcy estates (the “Estates”) in the above-captioned, jointly  
11 administered bankruptcy cases (collectively, the “Bankruptcy Cases”) of Porchlight  
12 Entertainment, Inc. (“PEI”) and Porchlight Distribution, Inc. (“PDI” and, together with PEI, the  
13 “Debtors”), shall come on for hearing in Courtroom 301 of the United States Bankruptcy Court  
14 for the Central District of California located at 21041 Burbank Boulevard, Woodland Hills, CA  
15 91367, the Honorable Martin Barash presiding.

16 By and through the Motion, pursuant to sections 363(b) and (f) of the Bankruptcy Code<sup>1</sup>  
17 the Trustee seeks authority to sell the Estates’ rights, titles, and interests in and to the Estates’  
18 properties, assets, and rights used in connection with the Debtors’ entertainment development,  
19 production, and/or distribution business (the “Assets”) to Legacy Distribution, LLC, a Georgia  
20 limited liability company (the “Buyer”) for the sum of Four Hundred and Fifty Thousand Dollars  
21 (\$450,000.00) (the “Purchase Price”) (the “Sale”) in accordance with the terms of the Asset  
22 Purchase Agreement (the “Agreement”), a true and correct copy of which is attached as **Exhibit**  
23 **A** to the Declaration of David K. Gottlieb (the “Gottlieb Decl.”) filed in support of the Motion.

### 16 **The Terms Of The Sale**

17 The salient terms of the Agreement provide as follows:

- 18 a. Buyer: Legacy Distribution, LLC;
- 19 b. Purchase Price: Four hundred fifty thousand dollars and zero cents (\$450,000.00);
- 20 c. Deposit: Thirty-five thousand dollars and zero cents (\$35,000.00);
- 21 d. Conditions of the Assets: The Assets shall be sold “as-is”, “where is” and without  
22 any representations or warranties, and free and clear of any and all liens and  
23 encumbrances to the extent permitted by 11 U.S.C. § 363(f);
- 24 e. Closing Date: The first business day after the Sale Order becomes a Final Order,<sup>2</sup>  
25 but no later than thirty (30) days after the order approving the sale (the “Sale  
26 Order”) becomes a Final Order; and
- 27 f. Buyer Protection: Break-up fee of ten thousand dollars and zero cents (\$10,000.00)  
28 (the “Break-Up Fee”) should the Buyer not be the winning bidder (as defined  
*infra*); and

26 <sup>1</sup> As used herein, “Bankruptcy Code” refers to title 11 of the United States Code (11 U.S.C. §§ 101, et  
27 seq.) and “section \_\_\_\_\_” refers to the specified section of the Bankruptcy Code.

28 <sup>2</sup> An order shall be deemed a “Final Order” fifteen (15) calendar days after its entry *provided that* (a) no  
timely appeal has been filed challenging the order or, (b) if a timely appeal has been filed, no order staying  
the effect of the order has been requested or entered. A notice of appeal shall be deemed timely if filed  
within the time allotted under Federal Rule of Bankruptcy Procedure 8002.

1 g. Broker's Commission: Fifteen percent (15%) of the first four hundred fifty  
2 thousand dollars and zero cents (\$450,000.00) in gross proceeds and seventeen and  
3 one half percent (17.5%) of gross proceeds in excess of four hundred fifty  
thousand dollars and zero cents (\$450,000.00) (the "Commission").

4 The Trustee is seeking authority to sell the Assets free and clear of all interest, liens,  
5 claims, and encumbrances pursuant to section 363(f). Furthermore, to the extent any secured  
6 creditor does not object to the relief sought by and through this Sale Motion, they each may be  
deemed to have consented to the sale free and clear of their lien, claim, or interest pursuant to §  
363(f)(2).

7 The Sale is supported by a valid business justification, and the Trustee believes that the  
8 Sale support the Trustee's business decision that the Sale is in the best interest of the Estates and  
9 their creditors. The Trustee employed an experienced and knowledgeable intellectual property  
10 broker to help devise a plan to effectively market and value the Assets. The Trustee marketed the  
11 Assets for sale for more than one year before entering into the Agreement. During that time, the  
12 Trustee aggressively priced the Assets in an effort to obtain the highest and best price for the  
13 Assets. The offer made by the Buyer was the highest and best offer. Based on the amount of the  
Purchase Price and the Buyer's demonstrated ability to close, the Trustee concluded the Purchase  
Price was the highest and best offer for the Assets. Additionally, the Trustee believes the terms  
reflected in the Agreement are in the best interest of the Estates.

14 The Buyer has acted in good faith and has agreed to pay fair market value for the Assets.  
15 The present transaction was negotiated at "arm's length" between the Trustee and the Buyer.  
16 Additionally, the Buyer is not an insider of the Trustee or either of the Debtors and no insider of  
the Trustee or either of the Debtors will receive special treatment as a result of the Sale.  
17 Furthermore, the Assets were sufficiently marketed to a wide range of potential purchasers, and  
the Sale is subject to the overbid procedures outlined below. For these reasons, the Trustee  
18 respectfully requests that the Court find that the Buyer qualifies as a "good faith purchaser" under  
§ 363(m) of the Bankruptcy Code.

19 **Approval of the Overbid Procedures is Warranted**

20 The proposed Sale is subject to overbid, which is designed to ensure the Estates receive  
21 the highest and best price for the Assets. In association with the proposed overbid auction (the  
22 "Overbid Auction"), the Trustee proposes the following procedures (collectively, the "Overbid  
Procedures"):

23 1. Notice of Intent to Bid/Deposit. Any party interested in bidding on the Assets  
24 during the Overbid Auction shall submit a written notice of intent to bid along with a cashiers'  
25 check in the amount of thirty five thousand dollars and zero cents (\$35,000.00) (the "Overbid  
Deposit") to the Trustee no less than two (2) business days prior to the date of the Sale Hearing;

26 2. Minimum Initial Overbid/Bid Increments. The minimum initial overbid during the  
27 Overbid Auction shall be no less than four hundred and seventy five thousand dollars and zero  
28 cents (\$475,000.00) (the "Initial Overbid") and, thereafter, each overbid shall be no less than ten  
thousand dollars and zero cents (\$10,000.00) (the "Bidding Increment") more than the  
immediately preceding bid;

1           3.     Proof of Ability To Overbid: On the date of the Overbid Auction, any bidder  
2 (other than the Buyer) who has complied with the procedures identified herein and who is  
3 interested in presenting one or more overbid(s) at the Overbid Auction shall be required to present  
4 a cashiers' check(s) to the Trustee evidencing the maximum amount he/she/it is willing and able  
5 to overbid. In no event shall this amount be less than the Initial Overbid;

6           4.     Back-up Bidder. If multiple offers are presented during the Overbid Auction, the  
7 highest and best offer shall be selected as the winning bid (the "Winning Bidder"). The  
8 individual or entity that offered the next highest and best offer (the "Back-up Bid") may elect to  
9 serve as the back-up bidder (the "Back-up Bidder"). In the event that (i) the Winning Bidder  
10 (other than the Purchaser) fails to close the Sale within the time allotted; (ii) the Purchaser has  
11 elected to serve as the Back-up Bidder; and (iii) the Purchaser fails to purchase the Assets within  
12 the time allotted, the Trustee shall solely retain or be entitled to recover the Deposit or Overbid  
13 Deposit, as applicable, as liquidated damages;

14           5.     Overbid Deposit Return. With the exception of the funds submitted by the  
15 Winning Bidder and/or Back-up Bidder, all Overbid Deposits shall be returned no later than five  
16 (5) business days after the conclusion of the Overbid Auction. If the Winning Bidder closes on  
17 the Sale, the Back-up Bidder shall be entitled to the return of his/her/its Overbid Deposit and/or  
18 any and all funds remitted to the Trustee in furtherance of the Purchase of the Assets no more  
19 than five (5) business days after the Closing Date;

20           6.     Bidding Order. Bidding during the Overbid Auction shall begin with the highest  
21 qualified overbid submitted prior to the Overbid Auction. During the Overbid Auction, the Buyer  
22 shall be entitled to offer the first bid in response to the opening bid. Thereafter, the order for the  
23 submission of bids shall be governed by the time at which the overbids were submitted prior to  
24 the Overbid Auction—the earliest overbid being entitled to submit the first bid after the Buyer.  
25 Bidding shall continue until a Winning Bidder and Back-up Bidder are selected; and

26           7.     No Telephonic Participation Permitted By Overbidders. Except for the Purchaser  
27 or the Purchaser's designated agent, any overbidder who wishes to participate in the Overbid  
28 Auction must be present (whether in person or through a designated agent) thereat; no telephonic  
participation at the Overbid Auction will be permitted (except for the Purchaser or the  
Purchaser's designated agent).

          The Trustee respectfully submits that the preceding procedures and requirements will  
serve to deter any casual bidders and protect the interests of the Estates. The Trustee further  
submits that the amount of the Initial Overbid (twenty five thousand dollars and zero cents  
(\$25,000.00) above the Purchase Price) is reasonable in light of the amount of the Purchase Price  
(i.e., four hundred fifty thousand dollars and zero cents (\$450,000.00)), and is not designed or  
intended to deter *bona fide* parties or chill bidding.

          The Trustee respectfully submits that the Break-Up Fee is reasonable under the  
circumstances presented. The Buyer has assumed the risks of serving as the stalking horse bidder  
for the proposed Sale. For instance, the Buyer has incurred fees and expenses in connection with  
the Agreement, and it is likely that the Buyer will continue incurring legal and transactional  
expenses up and through the Closing Date. In addition, the Break-Up Fee is not the product of  
self-dealing by the Trustee. The Trustee is not affiliated with the Buyer, and will receive no

1 personal benefit from the proposed transaction. Moreover, the Break-Up Fee is not likely to  
2 hamper or chill bidding on the Assets. Moreover, the amount of the Initial Overbid ensures that  
3 the Break-Up Fee can be satisfied while still presenting the entirety of the Purchase Price for the  
4 Estates. Finally, the Break-Up Fee is not unreasonably large as compared to the Purchase Price.

4 **Payment of Commission Upon Closing Is Warranted**

5 As the Trustee seeks to sell the Assets free and clear of all liens and encumbrances, the  
6 Trustee believes that payment of the Commission should be made immediately following the  
7 Closing Date. Pursuant to the Broker Order, the Broker is entitled to an advance of \$2,500 (the  
8 “Advance”) in addition to the Commission. Based on the foregoing, the Trustee requests  
9 authority to pay the Advance and the Commission in full on the Closing Date and/or immediately  
10 thereafter without further order of the Court.

9 **Tax Consequences**

10 The Trustee does not anticipate that any tax consequences will result from the sale of the  
11 Assets. However, if any taxes are owed by one or both of the Estates on account of the Sale, the  
12 Trustee shall pay the same in accordance with the Bankruptcy Code and any and all other  
13 applicable law.

13 **PLEASE TAKE FURTHER NOTICE** that pursuant to Local Bankruptcy Rule (“LBR”)  
14 9013-1(f)(1), any opposition or response to the Motion or the relief therein request must be set  
15 forth in writing and must be filed with the Court and served on counsel for the Trustee and the  
16 Office of the United States Trustee not later than fourteen (14) days before the Sale Hearing.

16 **PLEASE TAKE FURTHER NOTICE** that pursuant to LBR 9013-1(h), the Court may  
17 deem the failure to file a timely opposition or response to the Motion as consent to the granting of  
18 the Motion and relief requested therein.

18 **PLEASE TAKE FURTHER NOTICE** that a complete copy of the Motion and all  
19 documents filed in support thereof may be obtained by submitting a written request for the same  
20 to counsel for the Trustee via email addressed to ffarivar@foley.com. Upon receipt of such  
21 request, a copy of the Motion and all documents filed in support thereof shall be provided via  
22 email at the address from which the request for the same was transmitted.
