The Board discussed the recent changes in the complaint review process. Diane Meelheim will continue to conduct a staff review of all complaints and make recommendations for action. A Complaint Committee of Dr. Henry and Dr. Stratas was formed. They will review complaints between Board meetings and make recommendations for action by the Board. A summary of each complaint as well as the recommended action will be presented to the full Board for approval or amendments. Copies of all complaints will be available for Board review. (Note: As has been done in the past, if we receive a complaint of an urgent nature, an immediate investigation will be conducted and will come to the Board through the investigative review process.)

Page 15 - delete "or is eligible"

Page 6 - #3 Change of Primary Supervisor - delete "after one year"

Page 12 - 4A - "a physician will be on site a specific number of <u>days</u> a week" change the word days to hours.

Page 13 - strike the wording "at some period" at the top of that page

Page 14 - under #6(c) "physician must be able to perform any task he assigns to a PA" move to #5(d)

Page 22-23 REGISTRATION FEE - change to read "not to exceed \$200" or as determined by the Board.
Page 23 - raise application fee to \$200 and raise change of Primary fee to \$150.

As a result, the Board adopted a motion made by Dr. Patterson and seconded by Dr. Henry to approve the recommended changes mentioned above and to make note of the following concerns for future reference:

- Page 10 2D after "excluded by the formulary" add the wording "or not Board approved" (flag this recommendation and come back to after the formulary is revised and adopted)
- Page 13 (e) "Patients requiring <u>continuing care</u> should be seen by a supervising physician at least once every twelve months". ("continuing care" wording may be a problem no change was recommended)
- Page 13 Dr. Nance has concerns Re:(e) change to "primary physician must be on site a minimum
 of 4 hours every two weeks for rural health clinics as defined and 4 hours a week in all other
 sites" (No changes are to be made at this time regarding these concerns)

BOYD, Arthur, M.D.

A Public Hearing was held on November 12, 1992, regarding Dr. Arthur Boyd. As the result of certain information not being available during the Hearing, the Board delayed making any decision until the January 1993 meeting.

APPOINTMENT OF NEW MEMBERS

On November 11, 1992, the Board adopted a motion made by Dr. Spangler and seconded by Dr. Nance that the Board will request the month that Board members are appointed be moved to allow for more time to train the new members. This request will be submitted along with the Board request for a fee increase.

BOARD MEETING AUDIT BY FACILITATOR

On November 11, 1992, it was recommended that the facilitator from the Retreat be invited to review a Board meeting later in 1993 and audit its proceedings

As a result, the Board adopted a motion made by Dr. Patterson and seconded by Dr. Nance that Mike Weddington research to legality of having the facilitator attend the meeting.

NP JOINT SUBCOMMITTEE REPORT

On November 13, 1992, Dr. Nance reported that the NP Joint Subcommittee would like to appoint a task force to address formulary issues. As a result, the Board adopted a motion to have Mike Weddington talk with the Board of Nursing's attorney regarding the Board's views and concerns. Also that Cheryl Rachels, Diane Meelheim, Dr. Roufail and Dr. Godwin should meet to discuss how the Nurse Practitioner formulary needs to be integrated with the Physician Assistant's formulary.

GREEN. GWEN

On November 14, 1992, Dr. Spangler reported that Gwen Green's employment was terminated and that the Committee had sent her a letter thanking her for her many years of faithful service to the organization.

COMPUTERS

On November 14, 1992, Dr. Spangler reported that bids have been received from several companies including IBM and should be completed within the next two or three weeks which is included in the budget.

FAX MACHINES

On November 14, 1992, Dr. Spangler reported that the Committee is looking into bids for fax machines. Individual Board members will be polled by the staff to determine if they would like a private fax for Board business.

ACCESS TO LEGAL COUNSEL
